 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partner ships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of McGregor Group Ltd and Users. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, McGregor Group Ltd is the "data controller". This means that McGregor Group Ltd determines the purposes for which, and the manner in which, your Data is processed.

Data collected

5. We may collect the following Data, which includes personal Data, from you:

- a. name;
- b. gender;
- c. job title;
- d. contact Information such as email addresses and telephone numbers;
- e. IP address (automatically collected);
- f. web browser type and version (automatically collected);
- g. operating system (automatically collected);
- h. a list of URLs starting with a referring site, your activity on this Website, and the site you exit to (automatically collected);
- i. in each case, in accordance with this privacy policy.

How we collect Data

- 6. We collect Data in the following ways:
 - a. data is given to us by you; and
 - b. data is collected automatically.

Data that is given to us by you

- 7. McGregor Group Ltd will collect your Data in a number of ways, for example:
 - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
 - b. when you use our services;
 - c. verbally during telephone calls with McGregor Group employees;
 - in each case, in accordance with this privacy policy.

Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:
 - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

Our use of Data

- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience. Specifically, Data may be used by us for the following reasons:
 - a. internal record keeping;
 - b. improvement of our products / services;
 - c. transmission by email or other messaging system of marketing materials that may be of interest to you;
 - d. contact for market research purposes which may be done using email, telephone, fax or mail or other messaging service. Such information may be used to customise or update the Website;

in each case, in accordance with this privacy policy.

- 10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests (You have made a request for info on McGregor Group Ltd products, data processing is required to provide the info Your individual rights will be balanced against this), to fulfil our contractual obligations or legal obligations. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).
- 11. For the delivery of direct marketing to you via a messaging service, we'll need your consent, via a soft-opt-in:
 - a. soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and we are marketing similar products/services). Who we share Data with

- 13. We may share your Data with the following groups of people for the following reasons:

- c. third party service providers who provide services to us which require the processing of personal data to help third-party service providers (for example sub-contract installation companies) in receipt of any shared data to perform functions on our and clients behalf;
- d. third party payment providers who process payments made over the Website to enable third-party payment providers to process user payments and refunds;
- e. relevant authorities to facilitate the detection of crime or the collection of taxes or duties; in each case, in accordance with this privacy policy.

Keeping Data secure

- 14. We will use technical and organisational measures to safeguard your Data, for example:

Your rights

- 19. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - b. Right to correct the right to have your Data rectified if it is inaccurate or incomplete.
 - c. Right to erase the right to request that we delete or remove your Data from our systems.

- d. Right to restrict our use of your Data the right to "block" us from using your Data or limit the way in which we can use it.
- e. Right to data portability the right to request that we move, copy or transfer your Data.
- f. Right to object the right to object to our use of your Data including where we use it for our legitimate interests.
